The project seeks to research and develop solutions to increase resource efficiency and aircraft performance while cutting down on waste and material costs throughout the aircraft life cycle – aiming at "circular aviation".

Bio2Materials creates 'leather' from apples

The company Bio2Materials produces a [100% biodegradable 'leather' from apple pomace](#) – the main organic waste from fruit and vegetable processing in Poland. The final product is free of harmful substances, as it is an organic textile material composed of organic substances.
