Across the world, cluster organisations have taken a leading role in the green transition. Cluster Excellence Denmark recently released a new e-book titled [Towards a New Greener Normal – How Clusters are Dealing with Circular Transition in Times of COVID-19](#), exploring how this work has continued despite the current pandemic.

#### Wider environmental impacts of industry decarbonisation

Industry faces major challenges with regard to the transition to a net-zero greenhouse gas emissions economy by 2050. The [study](#) aims to provide an initial overview of the potential wider environmental impacts of the industry's transition within the scope of the Industry Emissions Directive (IED) to a low carbon economy, and to gain a better understanding of how IED facilities could contribute to a circular economy.

#### Alchemia-nova: treating waste water using green walls

[Alchemia-nova](#), Institute for innovative phytochemistry and closed loop processes, has collaborated with vertECO, GRETA & LooPi to develop three types of green walls, which treat wastewater to service water standards and create plant biomass and fertiliser.

#### Machiels Group: closing materials loops through enhanced landfill mining

Enhanced Landfill Mining (ELFM) of historic (and future) landfills is a key part of the solution for closing material loops. It addresses major societal challenges by recovering materials, energy and land. Machiels' ["Closing the Circle" project](#) will be the first to put ELM into practice.
